दिल्ली विधानसभा निवडणुकीच्या मतदानाला पाच दिवस राहिले असतानाच सत्ताधारी आम आदमी पक्षाच्या सात आमदारांनी राजीनामे दिले. पक्षाच्या नेतृत्वावरील विश्वास उडाला असून प्रामाणिक विचारसरणीपासून पक्ष दूर जात असल्याचे कारण देत या आमदारांनी राजीनाम्याचे अस्त्र उगारले. त्रिलोकपुरी मतदारसंघाचे आमदार रोहित कुमार मेहरौलिया यांनी दलित व वामकीर्ती समाजाच्या प्रगतीसाठी दिलेली आश्वासने पूर्ण

पक्षाने आरोप फेटाळले

या आमदारांनी केलेले आरोप आम आदमी पक्षाच्या प्रवक्त्या रीना गुप्ता यांनी फेटाळले. या आमदारांनी जनसेवेकडे दुर्लक्ष केल्याने त्यांना उमेदवारी देण्यात आली नाही. पक्षाने उमेदवारी न दिल्यामुळे त्यांनी राजीनामा दिला असून पक्षावर निरर्थक आरोप केले आहे. राजीनाम देत दुसऱ्या पक्षात जाण्याचा त्यांचा निर्णय संघीसाधूषणा आहे, असे गुप्ता म्हणाल्या.

'ब्रिक्स' देशांनी आंतरराष्ट्रीय व्यापारात अमेरिकेकडून डॉलरला पर्याय शोधण्याचा प्रयत्न केल्यास १०० टक्के शुल्क लादण्याचा इशारा पुन्हा अमेरिकेचे अध्यक्ष डोनाल्ड ट्रम्प यांनी दिले आहे. डॉलरला पर्यायासाठी देशांनी अन्य कोणत्या तरी भोळसट देशांचा शोध घ्यावा, असा सल्लाही ट्रम्प यांनी दिला आहे.



ट्रम्प यांनी शुक्रवारी 'दुथ सोशल' या स्वामालकीच्या समाजमाध्यम संदेशात सांगितले की, 'ब्रिक्स' देश डॉलरला पर्याय शोधण्याचा प्रयत्न करीत आहेत. परंतु आमचे त्यांकडे लक्ष असल्याने त्यांनी तसा विचार करणे सोडून द्यावे.
